A RESOLUTION APPROVING
AN AGREEMENT FOR THE PROVISION OF SERVICES BETWEEN DUPAGE TOWNSHIP
AND OPERATION CHRISTMAS: BOLINGBROOK (“OCB”)

WHEREAS, DuPage Township, Will County, State of Illinois (the “Township”) is a duly organized and existing township and a unit of local government organized under the laws of the State of Illinois and is operating under the provisions of the Illinois Township Code, 60 ILCS 1/1-1, *et. seq.*, and all laws amendatory thereto; and

WHEREAS, Operation Christmas: Bolingbrook (“OCB”) is an Illinois not-for-profit corporation providing a broad range of services for the benefit of the residents in and around DuPage Township including for social service needs of Township residents who may be considered poor and aged, among other purposes; and

WHEREAS, the Illinois Township Code authorizes the Township Board of Trustees to enter into contractual agreements with established organizations such as OCB, whether public or private, which provide social service needs for the poor and aged in the general area of the Township; and

WHEREAS, the Supervisor has caused to be drafted for and on behalf of the Township, an Agreement for the Provision of Services between the DuPage Township and Operation Christmas: Bolingbrook, which is attached hereto and incorporated in this Resolution as **Exhibit 1** (“Township – OCB Agreement”).

NOW, THEREFORE, BE IT RESOLVED by the Supervisor and Board of Trustees of DuPage Township, Will County, Illinois, as follows:

SECTION 1: That all of the recitals contained in the preambles to this Resolution are true and correct and are hereby incorporated into this Resolution by reference.

SECTION 2: The Township Board hereby approves the Agreement for the Provision of Services between the DuPage Township and Operation Christmas: Bolingbrook, attached to and incorporated into this Resolution as **Exhibit 1**.


SECTION 3: Any and all Resolutions or Ordinances of the Township which may conflict with this Resolution are hereby repealed.
