ORDINANCE NO. 21-22

AN ORDINANCE RESTRUCRUTING TOWNSHIP COMMITTEES

WHEREAS, DuPage Township, Will County, State of Illinois (the “Township”) is a duly organized and existing township and a unit of local government organized under the laws of the State of Illinois and is operating under the provisions of the Illinois Township Code, 60 ILCS 1/1-1, *et seq.*, and all laws amendatory thereto; and is an Illinois public entity operating under the laws of the State of Illinois; and

WHEREAS, the Supervisor and the Trustees of DuPage Township have determined that, in order to assist with the orderly and efficient conduct of Township business, the Township should eliminate certain advisory committees; and

WHEREAS, the Supervisor and Trustees of DuPage Township have determined it to be in the best interests of the Township to eliminate the advisory committees for: (i) Financial Advisory & Audit; (ii) Social Services and General Assistance Committee; (iii) Buildings, Assets, and Grounds Committee;

NOW, THEREFORE, BE IT ORDAINED BY THE SUPERVISOR AND TOWNSHIP BOARD OF DUPAGE TOWNSHIP, WILL COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: Recitals. The above recitals and findings are found to be true and correct and are incorporated herein and made a part hereof, as if fully set forth in their entirety.

SECTION 2: Repeal. Ordinance No. 19-10 of the DuPage Township Ordinances entitled “An Ordinance Establishing Advisory Committees for DuPage Township” is hereby repealed.


SECTION 3: Repeal. Ordinance No. 19-15 of the DuPage Township Ordinances entitled “An Ordinance Amending Ordinance Number 19-10 Establishing an Advisory Committee for

DuPage Township to Include the Establishment of a Social Services Advisory Committee” is hereby repealed.

SECTION 4: Repeal. Ordinance No. 19-19 of the DuPage Township Ordinances entitled “An Ordinance Amending DuPage Township Ordinance Number 19-10 and Ordinance Number 19-15 Establishing Advisory Committees for DuPage Township to Include the Establishment of a Buildings, Assets, and Grounds Committee” is hereby repealed.


SECTION 5: Effective Date. This Ordinance shall be in full force and effect immediately upon passage and approval by the Supervisor and Board of Trustees of DuPage Township, Will County, State of Illinois.
